REGULARITY TO CLASSES. CONDUCT AND DISCIPLINE:

1. I shall be regular to the classes and put up the required attendance in each subject
2. I shall conduct myself both within and outside the campus of the institute in such a manner to maintain the prestige and status of the institute.
3. I shall maintain highest degree of discipline and follow all rules made by the Institute from time to time in this regard. FINANCIALS :
